CITATION CONDITIONS

1. Responsibilities

Participating objects can not be transferred to another person. The participant has no right to transfer them for provided time, and also to hand over it in evidence to state or its organization.

Within organization with the Organizer (Chamber of Commerce and Industry of the Republic of Tajikistan) the participant bears responsibility for damage of the exhibition equipment and property. The participant bears responsibility for consequences (fire safety regulations, safety, sanitation and sanitary standards). In case of violation of the participant pays all the penalties which are applied by corresponding central authorities, and also compensates the cost of the caused damage.

2. Additional information

All exhibitions and their goods, imported for Exhibition-Fair are placed in "Temporary Admission" mode and must be returned to the same conditions. In this case the exhibitor is exempt from payment of Customs duties and taxes. During the exhibition-day if imported goods as part of them will be sold, then you should pay the Customs duties and taxes for the sold goods in accordance with the current legislation of the Republic of Tajikistan. It is obliged to have a certificate of manufacturer, standard or other documents certifying an origin and quality of certain goods. Certificates must be translated into Tajik or Russian languages.

3. Lease payment

The Chamber of Commerce and industry of the Republic of Tajikistan doesn't bear responsibility for losses, damage or damage which resulted from natural disasters, war, military operations, revolution, civil violence, possible or indefinite refusal of administrative authorities and etc. The force majeure circumstances accompanying or breaking up building a Exhibition-Fair, in this case the Chamber of Commerce and Industry of the Republic of Tajikistan reserves the right to postpone the date of exhibition-day at a later time. All rights goes to the Chamber of Commerce and Industry of the Republic of Tajikistan about the resulting an exhibition-day will be retained.

4. Dates

The dates of the exhibition day and opening day of the exhibition, through negotiations, are determined with the following prioritizing:
 • by 25% non fixed parameter;
 • date on each 9 square of the area;
 • 9 square areas.

5. Areas

(square foot area meter) in exchange of 17% of the cost of the exhibition area.

6. Payment

Participation fee is paid after signing and concluding agreement in period 10 calendar days before the opening of the exhibition on the official website of the organization.

7. Deadlines

Deadline for the concluding an October 15, 2024 (Tajikistan).

8. Dispute Resolution

Disputes shall have arisen and are not resolved out of court, through negotiations, are referred to the Arbitration Court of the Republic of Tajikistan.
